# Monthly Happenings:

In the past month, my focus has been digging deeper into program struggles with Directors.

- Fiscal Department Tyler, Chris, Joan & Deb have done phenomenal transitioning and meeting all the demands!
- Weatherization Kyle, Weatherization Director and Chris, Accountant, figured out how to submit monthly report as we had been having technical difficulty in prior months which Elisa, IT Director assisted with. Another example of intense team work in order to solve a problem!
- Housing Rural Set Aside grant has increased by \$100,000 for a new total of \$1,591,339 over a three-year period.
- **TBRA 7 Housing grant** in the amount of \$750,000 will be submit by Friday, May 19<sup>th</sup>. Historically, ICAA wrote and distributed to Community Action Agencies, but this year each agency was required to write their own.
- Spencer Outreach moved on May 11 & 12. Open House is being arranged for Thursday, June 29 3:30-5:30. Hope everyone will come see our new facility!
- Roosevelt Renovations are staying on schedule!

# Next Board Meeting:

- LIHEAP-23ES-16 UDMO requested an additional \$175,000 for our ECIP budget line. This involved moving \$3,115 from Assurance 16 and \$8115 to Program Support along with \$170,000 to ECIP.
- LIHWAP-21-ARPA-16 BA3 reallocation of \$230 from ECIP with \$145.34 going to Program Support and the other \$84.66 to Admin. It was also noted that this amendment also corrected a calculation error on BA2 that caused \$2,00 discrepancy in Program Support total.
- **DOE-23-16** New contract for 4/24/23-3/31/24 in the amount of \$479,447.00 for UDMO's Weatherization Program.
- **DOE-BIL-22-16** Updated Amendment 1 added Production funds to the contract. At the time of the contract, UDMO did not have an Admin percentage since we did not yet have production funds, which drives that percentage. So, it was now added to Amendment #1.

CACFP currently has 42 providers. 41 providers claimed for April. I indicated that I lost one provider from last month. Actually, that provider's license expired 3/31/2023 and she has not received her renewed Registration as of yet. So technically she did not quit, she is on hold until her license renews. The provider that did not claim for April had knee surgery and was out for the month.

I have my first in person, since the pandemic, State Conference in May. So hopefully some of our questions regarding tiering and territories will be answered.

#### I remain cautiously optimistic.

- Liheap ended on April 30th. Liheap moratorium ended April 1<sup>st</sup>. This means starting April 1<sup>st</sup>, vendors can start disconnecting Liheap clients for past due bills.
- LIHEAP APPLICATIONS: For April, Outreach took and processed 164 Liheap applications and of that number 153 were eligible.
- 11 denied and 0 on pending.
- Received 8 Online Liheap applications.
- Total amount to be paid \$6\$, 720.00.
- **YTD TOTALS**: Total applications 5,493. Total approved 5,250. Total amount to be paid \$71,200.00.
- Total amount issued to date \$2,664,400.00
- Crisis funds called: ECIP-Liheap Supplement-23ES. We have available for crisis with this new contract \$205,802. This was used up in April and we asked for an Amendment of \$170,000 to be put into ECIP/Crisis. This additional fund will be gone soon. State will be deciding if we will receive more ECIP/Crisis funds or if we will receive Supplemental funds. Will know next month on this outcome. LIHWAP ARPA Crisis has also been expended. Will know next month if we will get any additional funds for LIHWAP.
- CRISIS: 243 households received ECIP-Liheap Supplement 23ES Crisis funds in the amount of \$189,765.59. 135 households received LIHWAP ARPA Crisis funds in the amount of \$48,818.59.

#### Services: 0-5 family support services in Clay, Dickinson, O'Brien, Emmet, Palo Alto, Kossuth

The month of April seemed to go by rather fast with all of the Child Abuse Prevention Month activities. This included talking to area Board of Supervisors and sending out requests to meet with them in order to inform them of the Child Abuse Proclamation that we would like their support on signing. I am happy to report that Clay, O'Brien, Palo Alto Emmet, and Kossuth Counties all participated in signing proclamations. Articles were written in for the newspapers in Clay and Emmet County regarding Child Abuse Prevention Month. In addition, I completed the 3<sup>rd</sup> Quarter Reports that were due to Prevent Child Abuse Iowa on April 15<sup>th</sup>. They were received timely.



We continue to provide in home visits to client in the geographic area. We have continued to receive referrals on a continuous basis. We are looking at caseload capacity as we recently were made aware of the potential to have to complete two visits per month with each family. However, this is for programs that have Early Childhood Iowa funding. We also are beginning to update our Policies and Procedures within the KIDS Program to align with the Iowa Family Support Standards. So staff and I are working through these items to make sure that we are ensuring services are completed in a quality manner.

In addition, we continue to participate in any local and on-line training in order to meet our minimum number of hours of professional development of the year. We are required to have 40 hours of professional development per year. I will also be observing home visitors in the next two months on home visits.

The Weatherization Department for the month of April, completed 10 homes, it was a great month. We also received our DOEBILL22 infrastructure money that we have been waiting for months. It was finally approved by Department of Energy and we received \$438,321. Also, this month we received our regular DOE Funding as well for \$479,477. This is going to be great in assisting our clients in our 17-county area.

We also have been able to bring on another insulation contractor into our program, who will hopefully be able to assist in providing great service to our clients with the extra funding that we will be utilizing in the next 4years. The staff will be traveling to Spirit Lake June 14<sup>th</sup> and 15<sup>th</sup> for our annual IWAC Retreat. This should be a very informative retreat, and a chance to speak with current contractors. Until then we will continue to push hard and create results and effectively assist our clients with their energy needs on their homes in our 17-county area that we serve.

Head Start continues to maintain full enrollment with 176 Early Head Start students and 306 Head Start children.

I have been busy training staff and keeping up with the rental assistance demand. We are still awaiting the arrival of the contract for the Rural Unsheltered Housing Grant through the Iowa balance of State Continuum of Care. We recently attended an initial meeting with a HUD TA regarding the **new project** and are waiting for more information.

We are currently working on our application for Tenant Based Rental Assistance **(TBRA)** through the Iowa finance Authority.

Housing Staff will be attending the following **upcoming meetings**:

- $\bullet$  Housing Iowa Conference in Cedar Rapids September 6th  $8^{\rm th}$

We held a **Housing First Training** Meeting in Webster County on May 8<sup>th</sup>. This was a very informative meeting that helps people understand what it means to follow Housing First practices. We anticipate organizing additional Housing First Training Meetings in the upcoming months.

We are planning and organizing a **Focus Group** meeting in Buena Vista sometime during the month of June. This meeting will help us connect with other service providers in Buena Vista County. This meeting will include those with lived experience who have utilized our Housing Program services. We hope to gain understanding of what works well for our clients as well as what could be improved as they navigate through getting rental assistance in our Region.

Clients in need of rental assistance should call the **Statewide Crisis Line** at **1-833-739-0065** to complete the intake process. The state of Iowa Crisis Line is now reporting same day call backs in most cases. All calls are being returned within 24 hours

#### Sprinkler system

Prairie Fire Solutions, LLC has been installing the system. They have completed the gym, auditorium, and the third floor. They are working on the second level now. They have been working with the construction crew well and continue to be moving along well. The water line will be brought into the building next month (June) which should line up perfectly with the progress of the sprinkler guys.

#### **Classroom Remodel**

Christensen Construction, UDMO, and CMBA had a meeting recently to discuss progress. Everything is looking really good. Progress has been steady, but have also ran into some issues. The new doors are going to take some creative thinking and design for Christensen's due to type of material they are trying to attach the new door frames to. This is going to be a great place for the EHS children and staff when completed.

Quail Construction will have the building completed on April 14, 2023 by 5pm. Outreach has started moving into the new location. This will be a great upgrade for participants and staff.




Gardening Programs are starting in Clay, Hamilton, Humboldt and Wright!
