PROOF OF INCOME FOR <u>EVERYONE</u> LIVING IN THE HOUSEHOLD FULL-TIME FOR THE PAST 30 DAYS Do not need to include income of children in home age 0-17 who are working part-time and still in school. Full-time college students are only included in household if living at home full-time. All income must be from same timeframe for all household members.

		Family Investment Program (FIP) Benefits	Only need to know yes or no if received. No verification required	
		Worker's Compensation	Benefit statements	Benefit statements for the past year or statement from the payor
		Dividend Benefits	Letter or statement showing the amount received	1099 DIV or the most recent Federal Income Tax Return
		Unemployment Benefits	Printout from Workforce Development	1099 G or most recent Federal Income Tax Return
