 - c. Buena Vista CDC under budget \$(10,561) just beginning
 - d. Spencer CDC under budget (\$11,259), just beginning
 - e. WRAP Funding under budget (\$13,753)
 - f. School Funding Budget show under budget (112,952), but this program is just beginning, we will match staff and allocation codes, so next month will be more accurate. (Emmetsburg, Laurens, Storm Lake, Spencer, Milford, Estherville, Sheldon, Hartley)
 - g. In-Kind Head Start and Early Head Start has been entered through 7/31/23, Head Start is a little behind but will catch up with school beginning and EHS should reach the goal in October.
 - h. Credit Cards usage was shared with Policy Council for the Agency. The Visa/Walmart/Coop card statement explaining who uses the cards and what funds were spent on.
 - i. T&TA funds is being allocated on trainings that are scheduled for this fall.
 - j. HS Covid/Cares Fund, just waiting on Regional Office to approve items to close out this fund.

5. <u>Director's Report</u> – Irene Mayland, Head Start Director

- ERSEA Reports for August 31, 2023 shows under enrollment at 289 for Head Start and 176 for Early Head Start. Under enrollment is due to the Conversion of Slots written this spring and we are still waiting for this approval. Discussions with Region VII regarding this and they approve. This report for 23/24 with classrooms filled and maintain a waiting list.
- Attendance year to date is above 85% for both programs.
- Recruitment; we continue to recruit application for the 23/24 school year to maintain waiting list for any changes/withdrawals.
- ➤ Disabilities: Starting the year at 26/48 (54%) for the two programs, with children in referral. We will see this continue to increase.
- ➤ CACFP Report reviewed for August shows all meals claimed and one EHS classroom remaining closed with the cost of operating and reimbursement from CACFP.
- > Emmet- EHS classroom shared the open house today with a nice group touring the classrooms and building. Looks like we might get some volunteers from this also.
- ➤ Introduction of Alyssa Friesner to the group
