

CACFP currently had 36 providers claiming for December.

On a positive note, I did sign a new provider in Clay county on December 28<sup>th</sup>. She will begin claiming on January 2, 2024, which will put me back to 37 providers. From the CCR&R monthly list I have also been talking to a gal from Hull. I am trying to help her through the HHS licensing process. So, fingers crossed I can sign her in a month or two.

Recruitment efforts will continue. I will make monthly cold calls from CCR&R's list of people that have contacted their office inquiring about becoming registered day care providers. Currently there are zero licensed daycare providers in both O'Brien and Pocahontas counties.

- Liheap (Low Income Household Energy Assistance Program) is from November 1 April 30.
- Anyone that applies for Liheap and are eligible, cannot be disconnected from their electric or natural gas from Nov. 1 April 1. This is known as the Moratorium on winter disconnections.
- LIHEAP APPLICATIONS: For December, Outreach took and processed 591 Liheap applications and of that number 544 were eligible. 45 denied and 2 on pending.
- Received 61 Online Liheap Applications.
- YTD TOTALS: From 10-01-2023 to 12-31-2023: Total applications 4,195. Total eligible 3,995.
- Last year at this time: 4,143 applications were processed and 3,984 were eligible
- CRISIS: For December, 13 households received ECIP-Liheap Supplement 23ES also called ECIP 23 Extended Crisis funds in the amount of \$17,138.91. At this time, we are not assisting with crisis for Service Continuity, due to they are protected from being disconnected from the Moratorium.



Funding for all 501(c)3 organizations is very competitive and potential funding sources (Federal, State and Local) continue to request more information in their grant applications. Therefore, the information and data collected by all staff is instrumental in demonstrating the work the entire Upper Des Moines Opportunity, Inc. team does in making a difference in the lives of our consumers. Information being requested by potential funders includes:

- How will this project benefit the citizens of the community?
- Who are other partners are in this project?
- How do you know the project is making a difference or having a positive impact?

#### Focus Area 1: Meeting with Primary Care Physicians/Clinics

- 1<sup>st</sup> Five delivered handwritten holiday cards, chocolates, referral form, updated Iowa HHS 1<sup>st</sup> Five brochure to clinics in the 7-county service area.
- 1<sup>st</sup> Five Site Coordinator and Medical Peer Champion continues to work towards scheduling peer consultation with UnityPoint Family Medicine in Pocahontas County.
- 1<sup>st</sup> Five encourages accredited developmental screening at well-child visits and if a delay or concern is identified a simple referral to UDMO 1<sup>st</sup> Five to help connect family with local resources.

#### **Focus Area 2: Meeting with Community Partners**

- Meredith continues to share information about 1<sup>st</sup> Five by attending community partner meetings in person or virtually. Information gathered at these community partner meetings/events is shared with 1<sup>st</sup> Five Developmental Support Specialists and/or other community partners. 1<sup>st</sup> Five promotional items, screening, EPSDT guidance are all available and distributed at these meetings/events.
- 1<sup>st</sup> Five Site Coordinator continues to reach out to be active with county community events and partnership meetings **Focus Area 3: Referrals/Communication with Families:**
- Upper Des Moines Opportunity 1<sup>st</sup> Five continues to help support referred children and their families with services.
- Documentation into Iowa Connected Iowa HHS data entry system encouraged same day, but completion within 10 calendar days.



#### **1st/Five Continued:**

#### **On-Going Efforts/Upcoming Changes:**

- Staff supervisions written summaries & required Iowa HHS training and verification before subcontract payments are processed through UDMO. All subcontracts are complying.
- Fiscal end of year review discussion of moving shared UDMO DSS, Kristi Radtke, to CSA1 & CSA4 to 100% in CSA1. Then fiscal discussion of CSA4 discussion of subcontracts and posting a new position of internal UDMO Developmental Support Specialist Family worker to cover increasing need, referrals and help provide additional coverage support within CSA4's 7 county service area and subcontract overflow.

#### **KIDS Program-Jessie Hansen**

The month of December has been incredibly busy! In December, we completed our group parent education meetings virtually. We had one participant and it was a great group. We will be offering this again in the Spring. For our individual services, we continue to receive referrals on an on-going basis and evaluate caseload sizes, include referrals for Palo Alto County. We also have a new worker Hailey Ferguson that will be starting January 8<sup>th</sup> and serving Palo Alto County under the Early Childhood North Central Iowa Contract. She will be in the process of training her through March when she will be able to provide visits on her own.

Quarterly reports are due January 15<sup>th</sup> and I will be working on getting those completed on time. I also scheduled home visit observations in December and due to the holidays and illness, we were unable to get them completed.

#### **Weatherization Update:**

The Weatherization Department for the month of December we completed 15 homes more than our average. We were a little short of our goal of 110, but between contractors and weather I am very pleased how close we came to getting this number of homes completed. As far as the rest of the month not much for changes or new announcements for the Weatherization program, but we did receive notice from the state that we should be receiving our new contracts sometime in January 2024 from the State which is our HEAP contract and from our 3 Utility Vendors BHE (Black Hills Energy), MEC (MidAmerican Energy), and IPL (Alliant Energy). Then of course we will get our DOE (Department of Energy) funding at the beginning of March of 2024. I am looking forward to FY24 year to start and see what the future holds for our program and our employees moving forward and see what results we can accomplish and how many families we can impact in a positive way through our program.

Until then we will continue to push hard and create results and effectively assist our clients with their energy needs on their homes in our 17- county area that we serve.

**Statewide Crisis Line Update:** Clients in need of rental assistance should call the **Statewide Crisis Line** at 1-833-739-0065 to complete the intake process. Due to staffing shortages the Call Center is reporting delayed call backs. UDMO Housing staff are accommodating as many as possible with the intake process to help alleviate long wait times.

Effective January 1, 2024 the Statewide Crisis Line will no longer offer 24/7 live operator service. Normal business hours will be 7am-8pm. Clients calling outside of these hours will still be able to leave a message and will be triaged the next business day.







