LEGISLATION & ADVOCACY GOVERNMENT REOPENS – HOUSE AND SENATE BEGIN WORKING ON THE BUDGET.

DECEMBER 3RD, THE FULL HOUSE ENERGY AND COMMERCE COMMITTEE UNANIMOUSLY PASSED AN AMENDED VERSION OF HR 1355, "WEATHERIZATION ENHANCEMENT AND READINESS ACT OF 2025." THE BILL WOULD REAUTHORIZE WEATHERIZATION ASSISTANCE PROGRAM FUNDING THROUGH FY30, WITH THE FOLLOWING APPROPRIATIONS:

- · FY26-FY28: \$300 MILLION ANNUALLY
- · FY29: \$325 MILLION
- · FY30: \$350 MILLION

THIS LEVEL OF BIPARTISAN SUPPORT IS NOTABLE AND ENCOURAGING.



AGENCY HIGHLIGHTS & PROGRAM UPDATES

COUNTY SUPERVISOR VISITS

DISTRIBUTION OF UDMO'S ANNUAL REPORT TO COUNTY SUPERVISORS IS UNDERWAY. THIS YEAR'S RELEASE WAS SLIGHTLY DELAYED DUE TO THE LAUNCH OF TWO NEW DATA SYSTEMS. WHILE THE REPORTS LOOK DIFFERENT FROM PRIOR YEARS AND COMPARISONS ARE MORE CHALLENGING, THE NEW SYSTEMS NOW ALLOW US TO GATHER UNDUPLICATED HOUSEHOLD COUNTS, A VALUABLE IMPROVEMENT.

UDMO FISCAL AUDIT

WIPFLI CONDUCTED THE AGENCY'S ANNUAL FISCAL AUDIT DURING THE LAST WEEK OF NOVEMBER. A FULL REPORT WILL BE SHARED WHEN AVAILABLE.

FISCAL YEAR-END ACTIVITIES

ALL PROGRAMS ARE FINALIZING SERVICE DATA FOR YEAR-END REPORTING, INCLUDING THE PREPARATION OF UDMO'S ANNUAL REPORT AND REQUIRED FUNDER REPORTS.

FISCAL & HR - UKG IMPLEMENTATION

FISCAL AND HR STAFF HAVE BEEN WORKING DILIGENTLY ON THE TRANSITION TO UKG. THIS IS A MAJOR UNDERTAKING, AND WE EXTEND SINCERE APPRECIATION TO ASHLEY, TIFFANY, AND TYLER FOR THEIR DEDICATION. THE TEAM WILL TRAVEL TO EACH UDMO SITE TO TRAIN EMPLOYEES ON THE NEW SYSTEM.

LIHEAP

UDMO CONTINUES TO ACCEPT APPLICATIONS TO HELP ELIGIBLE HOUSEHOLDS PREVENT UTILITY DISCONNECTIONS THROUGH MARCH. DEMAND REMAINS STEADY.

HEAD START

HEAD START PROGRAMS CONTINUE TO OPERATE AS USUAL. FAMILIES IN THE HEAD START PRESCHOOL PROGRAM ARE ENCOURAGED TO APPLY FOR CHILD CARE ASSISTANCE TO SUPPORT FULL-DAY SERVICES, AS ONLY HALF OF OUR PRESCHOOL CLASSROOMS CURRENTLY RECEIVE FULL-DAY FUNDING.

OUTREACH FOOD PANTRIES

FOOD PANTRY DEMAND INCREASED IN NOVEMBER DUE TO THE DELAYED RELEASE OF SNAP BENEFITS AND THE FEDERAL GOVERNMENT SHUTDOWN. AS SUPPLIES RAN LOW, OUR COMMUNITIES RESPONDED GENEROUSLY WITH FOOD AND MONETARY DONATIONS. WE ARE DEEPLY GRATEFUL FOR THIS SUPPORT.

OUTREACH HOLIDAY PROGRAMS

HOUSING REPORT NOVEMBER 2025 - TANYA PETERSEN, HOUSING DIRECTOR

71 HOUSEHOLDS RECEIVED RENTAL ASSISTANCE IN THE MONTH OF NOVEMBER.

THE FISCAL YEAR 2025 IOWA BALANCE OF STATE CONTINUUM OF CARE GRANT COMPETITION HAS OPENED. WE ARE CURRENTLY WORKING ON OUR SUBMISSION. THE DEADLINE IS DECEMBER 12, 2025 AT 12PM.

CLIENT SUCCESS STORIES BY STAFF

DURING THIS MONTH'S SCHEDULED HOME VISIT FOR RECERTIFICATION, I MET WITH THE CLIENT AND HER FAMILY TO REVIEW THEIR CURRENT SITUATION AND ADDRESS ANY NEW NEEDS. THE CLIENT SHARED THAT THEIR HOUSEHOLD HAS RECENTLY WELCOMED A YOUNG CHILD INTO THEIR HOME FULL-TIME. THIS TRANSITION HAS BROUGHT BOTH JOY AND NEW CHALLENGES, AS THE FAMILY HAS BEEN NAVIGATING BEHAVIORAL CONCERNS, CLOTHING NEEDS FOR THE CHILD AND HIS TWO SIBLINGS, AND OTHER RELATED ADJUSTMENTS.

TOGETHER, WE TOOK TIME TO DISCUSS THEIR CONCERNS IN DETAIL AND EXPLORE PRACTICAL SOLUTIONS. I PROVIDED INFORMATION AND REFERRALS TO SEVERAL COMMUNITY AGENCIES THAT COULD ASSIST WITH CLOTHING, BEHAVIORAL SUPPORTS, AND FAMILY RESOURCES. ADDITIONALLY, I COORDINATED A MEETING WITH THE DIRECTOR OF SPECIAL EDUCATION AT THE LOCAL SCHOOL DISTRICT TO ENSURE THE FAMILY'S CONCERNS WERE HEARD AND THAT THE CHILDREN'S EDUCATIONAL AND EMOTIONAL NEEDS ARE BEING PROPERLY ADDRESSED. THE GOAL WAS TO STRENGTHEN COLLABORATION BETWEEN THE FAMILY AND THE SCHOOL TO SUPPORT EACH CHILD'S SUCCESS.

THE FOLLOWING DAY, I CONDUCTED A FOLLOW-UP CALL TO CHECK ON THE FAMILY'S PROGRESS WITH THE REFERRALS. THE CLIENT SHARED THAT SHE HAD ALREADY MADE CONTACT WITH SEVERAL AGENCIES AND HAD BEGUN RECEIVING ASSISTANCE. SHE EXPRESSED DEEP APPRECIATION, STATING THAT I HAD DONE MORE TO SUPPORT HER FAMILY IN 24 HOURS THAN OTHER AGENCIES HAD ACCOMPLISHED IN MONTHS.

IT WAS REWARDING TO HEAR THAT FEEDBACK AND TO SEE THE FAMILY'S SENSE OF RELIEF AND RENEWED HOPE. MOMENTS LIKE THESE REINFORCE THE IMPORTANCE OF PROVIDING NOT ONLY HOUSING ASSISTANCE BUT ALSO COMPREHENSIVE CASE MANAGEMENT, ONGOING SUPPORT, AND COMPASSIONATE GUIDANCE TO HELP FAMILIES THRIVE IN ALL AREAS OF THEIR LIVES.

STATEWIDE CRISIS LINE UPDATE: CLIENTS IN NEED OF RENTAL ASSISTANCE SHOULD CALL THE STATEWIDE CRISIS LINE AT 1-833-739-0065 TO COMPLETE THE INTAKE PROCESS. NORMAL BUSINESS HOURS ARE 7AM – 8PM. CLIENTS CALLING OUTSIDE OF THESE HOURS WILL NEED TO LEAVE A MESSAGE AND WAIT FOR A CALL BACK. CALL BACKS ARE BEING MADE USUALLY WITHIN 1-3 BUSINESS DAYS.

 OCT. 1ST FOR A HOUSEHOLD WITH AN ELDERLY (60 YEARS OF AGE OR OLDER)
 AND/OR A DISABLED HOUSEHOLD MEMBER. ALSO, ANY HOUSEHOLD IN A CRISIS
 RELATED SITUATION MAY APPLY FOR LIHEAP IN OCTOBER. EVERYONE ELSE CAN
 APPLY NOV. 1ST THRU APRIL 30TH.
- LIHEAP APPLICATIONS: FOR NOVEMBER, OUTREACH TOOK AND PROCESSED 813
 LIHEAP APPLICATIONS. THIS REPORT FROM STATE INCLUDES ONLINE AND DENIED APPLICATIONS IN IT.
- ECIP/CRISIS: WE HAVE STOPPED ALL ECIP/CRISIS AS OF OCT. 27TH. WE MAY START UP AGAIN WITH THIS ONCE STATE UPDATES ALLOCATION AMOUNTS.

THE WEATHERIZATION DEPARTMENT COMPLETED 10 HOMES IN NOVEMBER, ALLOWING US TO REACH OUR ANNUAL GOAL OF 110 HOMES ONE MONTH AHEAD OF SCHEDULE. I WANT TO EXTEND A SINCERE THANK YOU TO ALL OUR STAFF AND WEATHERIZATION CONTRACTORS FOR THEIR HARD WORK AND DEDICATION. MEETING THIS GOAL EACH YEAR IS A SIGNIFICANT CHALLENGE, AND YOUR COMMITMENT IS WHAT MAKES IT POSSIBLE.

THERE ARE NO MAJOR PROGRAM CHANGES THIS MONTH; HOWEVER, WE DO HAVE ONE IMPORTANT UPDATE REGARDING VERMICULITE. PROGRAM GUIDELINES NOW REQUIRE ALL STAFF TO HOLD AN ASBESTOS CERTIFICATION AND LICENSE BEFORE HANDLING VERMICULITE. WHILE MANY OF US HAVE PREVIOUSLY COMPLETED THE CERTIFICATION, LICENSING WAS NOT REQUIRED UNTIL RECENTLY. WE ARE CURRENTLY SCHEDULING A REFRESHER COURSE AND WORKING WITH A PROCTOR TO ENSURE ALL TEAM MEMBERS ARE FULLY CERTIFIED AND LICENSED.

UNTIL THESE REQUIREMENTS ARE COMPLETE, ANY HOME CONTAINING ASBESTOS MATERIALS—SUCH AS VERMICULITE INSULATION—WILL NEED TO BE DEFERRED. ONCE OUR CERTIFICATION AND LICENSING ARE FINALIZED, WE WILL RESUME WORK ON THESE HOMES AND CONTINUE SAMPLING AS NEEDED. AS ALWAYS, WE REMAIN COMMITTED TO DELIVERING STRONG RESULTS AND SUPPORTING THE ENERGY NEEDS OF HOUSEHOLDS ACROSS OUR 17-COUNTY SERVICE AREA.


