 Legislation & Advocacy

### Federal Update

The federal government has reopened, and both the House and Senate have resumed work on the budget. As of mid-January, updates remain limited; however, progress continues at the appropriations level.

The House and Senate Energy and Water Subcommittee appropriators have reached agreement on the final FY2026 Energy and Water Appropriations Bill, with the following outcomes:

- Weatherization Assistance Program: \$329 million
- Weatherization Readiness Fund: \$30 million
- DOE Technical Training & Assistance (TTA): \$10 million (level-funded with FY2025)

We anticipate that several appropriations bills, including Energy and Water, will be completed in early January. The next step will be House and Senate floor action, and all indications remain positive for passage.

We continue to project that the final FY2026 Labor-HHS Appropriations bill—which includes CSBG, LIHEAP, Head Start, and other key programs—will be completed shortly before the January 30 Continuing Resolution (CR) deadline.

### Head Start Advocacy

Head Start Director Sarina, along with Development Director Shakira, will travel to Washington, D.C. during the last week of January to advocate for our programs. They have scheduled in-person meetings with Senator Ernst, Senator Grassley, and Representative Feenstra, all of whom have historically been strong supporters of Head Start.

### Iowa Community Action Association (ICAA)

The Iowa Community Action Association will host its annual Day on the Hill in Des Moines on January 27. This advocacy event provides an opportunity to engage directly with local legislators on issues impacting community action agencies across the state.

### FaDSS Advocacy Day

An advocacy event at the State Capitol in Des Moines with local legislators. The event will highlight the program's impact on family stability, economic independence, and workforce entry, sharing success stories to support continued funding and legislative backing.

## **Agency Highlights & Program Updates**

### **County Supervisor Visits & Annual Report Distribution**

Distribution of UDMO's Annual Report to county supervisors is underway. This year's release was slightly delayed due to the implementation of two new data systems. While the format differs from prior years and year-to-year comparisons are more challenging, these systems now allow us to capture unduplicated household counts, a significant improvement in data quality. Completed distributions: Buena Vista, Clay, Dickinson, Emmet, Hamilton, Humboldt, Osceola, Palo Alto, Pocahontas, and Wright Counties.

Remaining counties: O'Brien and Webster.

### **Fiscal & HR Update – UKG Activation**

Fiscal and HR staff successfully completed the first payroll processed through UKG. While there were a few expected challenges, overall implementation issues were minimal. Ashley, Tiffany, and Tyler continue to meet weekly with UKG representatives as we expand system functionality and optimize use.

### **Fort Dodge Facility Search**

Due to continued program growth and increased staffing needs, UDMO is actively seeking a larger facility in Fort Dodge to better support employees serving Webster County and surrounding areas.

### **Estherville Outreach Relocation**

Estherville Outreach has officially relocated to the back (west side) of the Roosevelt Building. Sincere thanks go to Outreach volunteers and Central Office staff who assisted with hauling and organizing over multiple days.

We also extend special appreciation to Estherville Head Start staff for their outstanding support and hospitality. Their willingness to assist Outreach staff, contractors, and client's day after day exemplifies teamwork at its best. While we are still settling into the new space, this transition would not have been possible without such collaboration.

### **Restore Hope Grant**

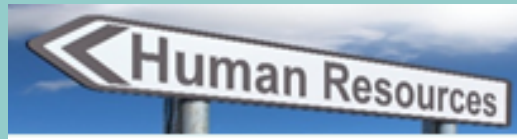

## Area youth groups help provide food relief

Two projects by Osceola County church youth groups will help provide meals for those in the community struggling with food insecurity.

More than a dozen members of the religious education program in grades 7-11 at St. Andrew Catholic Church in Sibley attended the Called Youth Conference on Saturday, Nov. 2, in Granville.

As part of a service project organized for the event, the students collected green beans, corn and stuffing mix to bring to the conference.

The donated items were combined with contributions from eight other churches to assemble 300 meal bags with ingredients for Thanksgiving dinner side dishes.

Sixty of those bags made their way to the Upper Des Moines Opportunity of Osceola County office in Sibley.

### Food collection Nov. 19

Another food drive event will take place Wednesday, Nov. 19. The Osceola County Ministerial Association will again hold its

annual food find that evening.

Paper grocery sacks with a letter explaining the event were distributed throughout the community on Wednesday, Nov. 5.

Directions in the letter ask that residents fill the bag with non-perishable food items that will be donated to Upper Des Moines Opportunity.

Simply leave the bag outside an entrance door with an exterior light turned on. Volunteers will pick up the bags that evening after 6:30 p.m.

Residents who did not receive a bag or missed having items picked up can drop them off on Nov. 20 at Celebrate Church, 418 Ninth St. in Sibley, or call pastor Josh Tange-man at 712-461-2610 to arrange a time to have the bag picked up.

Outreach specialist Pam Braun of UDMO said all items are welcome as everyone's tastes vary, but certain items deplete more quickly.

"We could really use instant potatoes, sugar, ketchup, cereal, syrup, pancake mix, mandarin oranges, French-style green beans, creamed corn, canned chicken or other canned meats, flavored rice and Chef Boyardee products," Braun said.

## Upper Des Moines Opportunity spends \$476,563 to assist Hamilton County residents in 2025

During the monthly meeting of the Hamilton County Supervisors, Julie Edwards, Executive Director of Upper Des Moines Opportunity – UDMO – gave an update on the services provided to Hamilton County residents during 2025.

Their mission, according to Edwards is "to address the effects of poverty on individuals and families and build stronger communities." Their programs range from food and housing to weatherization and childcare, just to name a few ways their assistance is used.

UDMO serves 22 counties in Iowa. In addition to Hamilton county, they serve Lyon, Sioux, Osceola, O'Brien, Dickinson, Clay, Buena Vista, Sac, Emmet, Palo Alto, Pocahontas, Calhoun, Kossuth, Humboldt, Webster, Winnebago, Hancock, Wright, Worth, Cerro Gordo and Hardin.

During 2025, she reported assistance to 506 households in Hamilton County from their programs. Assistance with energy needs was used by 303 households, while addressing housing downpayments or deposits were just two

households, and weatherization news were 12 households.

Direct assistance to these households totaled \$476,563 in 2025

The demographics of the age groups that the assistance programs helped in Hamilton County in 2025 were as follows:

36% are children aged 0-17

42% are age 18 to 59

22% of individuals are over the age of 60 or retired.

In addition, 25 individuals are Veterans or active military.

35% of the individuals are employed

25% report a disabling condition

46% are a single person household

14% are led by a single female parent

42% of the households assisted own their own home

25% of households have a total annual income at or below poverty level

36% of households also have SNAP

During her presentation, Edwards requested a continued partnership with Hamilton County and an investment of \$18,000 for 2026.

### Client Success Stories by Staff

This month we helped house many clients who were experiencing homelessness and literally living on the streets, including one mother and her children who were living in a hotel room. With colder weather, we had an increasing need to find warm homes. It was especially incredible working with landlords who jumped in and provided paper products and cards to our clients when they heard their stories as well. Pastor Dani at the SALT Center has been a great resource this last month for finding clients who do not have a phone and letting them know which days we will be there. It is so heartwarming to know we have curated a “village” of supporters who go above and beyond to meet our clients' individual needs.

Statewide Crisis Line Update: Clients in need of rental assistance should call the Statewide Crisis Line at **1-833-739-0065** to complete the intake process. Normal business hours are 7am – 8pm. Clients calling outside of these hours will need to leave a message and wait for a call back. Call backs are being made usually within 1-3 business day

**Weatherization Update:**

The Weatherization Department had another strong month in December, completing an additional 10 homes. We are proud to close out the year having exceeded our annual goal of 110 homes by completing a total of 120 homes in FY 2025. This accomplishment reflects the hard work and dedication of our Weatherization team, as well as the quality and commitment of the contractors we partner with to support this outstanding program.

Throughout the year, our program successfully navigated significant changes, including funding adjustments and major updates to program policies and procedures. These included implementing updated program standards, transitioning our NEAT program, and moving from a bid-based system to a flat-rate process, along with the internal changes required to support that transition.

We also experienced another major change with the new requirement to be certified and licensed by the State of Iowa for asbestos sampling. We are currently in the process of obtaining this certification and anticipate having it completed by the end of January, which will allow us to conduct asbestos sampling directly in our clients' homes.



· LIHEAP (Low Income Household Energy Assistance Program) starts Oct. 1st for a household with an elderly (60 years of age or older) and/or a disabled household member. Everyone else can apply Nov. 1st thru April 30th.

· Anyone that applies for Liheap and are eligible, cannot be disconnected from their electric or natural gas from

Nov. 1 – April 1. This is known as the Moratorium on winter disconnections.

· LIHEAP APPLICATIONS: For December, Outreach took and processed 537 Liheap applications.

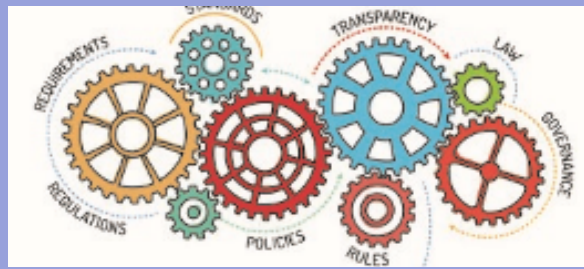

· YTD TOTALS: From 10-01-2025 to 12-31-2025 - Total applications 3,462.

· LAST YEAR AT THIS TIME: 3,174 applications were completed.

· ECIP/CRISIS: We have stopped all ECIP/Crisis as of Oct. 27th. To date we have not started this back up. We are anticipating that we will have to request an amendment next month to move ECIP funds into Regular Assistance funds to help pay Liheap applications.

Many County Community Foundations run grant cycles from October through March, making recent months especially busy. During this time, we’ve attended grant meetings, collaborated to identify program and facility needs, gathered supporting data, secured bids, and submitted grant requests. We’ve also prepared reports for counties and cities and met with County Boards of Supervisors to provide updates on UDMO services in their communities.

UDMO continues to pursue funding for food pantries, Outreach client services, Head Start equipment, and ADA accessibility improvements. Thank you to the program directors and staff who collaborate in this work and help ensure timely, complete grant submissions.

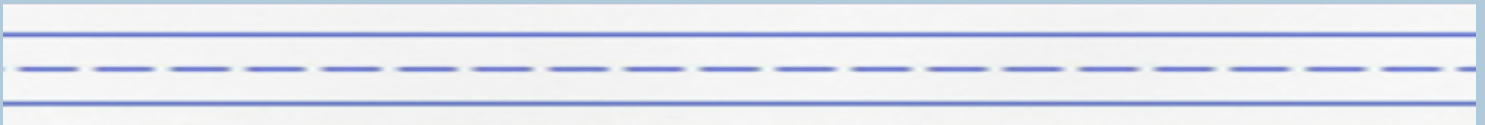
